Community Outreach by Ellen Rulseh, Community Outreach and Citizen Monitoring Coordinator

In 2003 we helped implement the mission of the Rock River Coalition in schools, civic and friends groups, with individuals, the media, and RRC members in a variety of ways.

Among the many initiatives undertaken was an "Environmental Action" booklet that lists projects anyone can do to improve water quality in the Rock River Basin.

Two demonstration rain gardens were coordinated, one in cooperation with youth and staff at Centro Hispano and Saint Mark's Lutheran Church in Madison and the other with UW-Extension staff and workshop volunteers in Jefferson. School groups at Webster School in Watertown and Jefferson Middle School have undertaken rain garden implementation. Partnerships have been formed with Horicon Parks Department and Hustisford High School for demonstration rain gardens planned for early summer of 2004.

Another outcome of outreach to schools in Watertown, Jefferson, and Fort Atkinson is a new partnership with Wisconsin's K-12 Energy Education Program (KEEP) and the DNR's "Green Schools" program. Energy audits educate teachers, administration and students about how school buildings can save money by being energy efficient.

Early in 2003 we coordinated a "Sense of Place" meeting in Mayville with more than 15 people representing Watertown, Horicon, Hustisford, Waupun and Mayville to plan events. Juneau has also joined the initiative.

We are working with Watertown's Main Street Program, the Jefferson County Board Supervisors, and the City of Watertown to promote Watertown's Riverwalk in 2004.

2003 was a year of building relationships while developing new partnerships and continuously promoting the Rock River Coalition.

A Word from Our DNR Partners

A two billion-dollar deficit in state government has spurred lots of changes in 2003. The Department of Natural Resources has been asked to down size and cut many of its budgets. The task in front of the Department is to figure out ways to provide the same level of public service with less resources. While I'm confident we'll do the best job possible working with the resources we've been given, the partnership that we've forged with groups like the Rock River Coalition, now more than ever, needs to take center stage. The idea behind forming partnerships has always been to take advantage of synergistic and do more with less. Rock River Basin Partnership Team Highlights

Groundwater Issue Team

Groundwater Guardians & GFLOW Model

The Rock River Coalition (RRC) Groundwater Issue Team received the first annual Groundwater Guardian Team Award for their work on the Karst Display, Well Abandonment Workshops, and GFLOW Model proposal. The team continues to work on the development of a GFLOW model for the basin.

Rural Development Concerns Issue Team

Rock River Basin Rural Development Guidelines and Policies Manual

The Rock River Coalition (RRC) Rural Development Issue Team published the Rock River Coalition Rural Development Guidelines and Policies Manual. It describes the reasons for focusing development in specific areas and methods to protect and enhance agriculture in the Rock River Basin. Informational meetings were held in Watertown and Stoughton with 84 participants including elected officials, planning professionals, land trusts and other interested individuals. The team continues to make presentations on the manual contents to interested organizations and town board committees. Four town board committees and a county Farm Board committee were given presentations during 2003. The manual is on the web at <http://clean-water.uwex.edu/rockriver>.

“Changing Landscapes: Anticipating the Effects of Local Decisions”

The Rock River Coalition was a co-sponsor for a number of events during 2003. The Changing Landscapes Workshop was one of the most important for our issue teams. Professional planners and others involved in encouraging citizen participation in local land use decisions came together to evaluate computer land use decision-support tools. This will be followed up with another workshop in 2004. The Rock River Coalition will then host citizen workshops in late 2004 or 2005.

Water Quality Issue Team

Citizen Monitoring

The citizen monitoring project was expanded in 2003 to include Jefferson, lower Dodge, Columbia and Walworth counties so all counties in the Rock River Basin now have citizen stream monitors. Streams in all ten counties were prioritized for those where information needs were most critical. In each county we have local coordinators who work with the monitors. The local coordinator works first to find monitors who will focus their efforts in these priority areas. The RRC also encourages monitors to select sites where they have a personal interest, their ‘home town stream’.

More than 150 citizens have been trained in monitoring techniques with 129 active stream monitors. Each year an advanced program is offered to veteran monitors. This event, “Rock River Basin Confluence, a Gathering of Citizen Monitors,” was held on March 8, 2003 with forty-six people attending. Suzanne Wade, UWEX Basin Educator received the Wisconsin Citizen Stream Monitoring Pioneer Award for her work in the Rock River Basin as well as earlier work in the Milwaukee River Basin.

Storm Water Issue Team

“Managing Storm Water in the Rock River Basin: A Practical Approach”

The basin Storm Water Issue Team hosted two workshops on Storm Water Management with 64 people in attendance. Rain garden workshops and demonstrations were developed at UW-Extension in Jefferson County.

Dane County NR 216 Storm Water Information and Education Plan and Citizen Assessment

Nineteen communities in the greater Madison Area developed a Storm Water Information and Education Plan. Members of the RRC Storm Water Issue Team participated in the project. The effort won the Wisconsin Extension Community Development Association 2003 Team Award. The effort continues with a survey of attitudes, knowledge and actions concerning storm water, and the development of media messages.

Shoreline and Wetland Protection Issue Team

Shoreline Restoration Initiative

The Rock River Coalition Shoreline Restoration Initiative completed 5 shoreline restoration/erosion control projects in 2003. Since 2002 twelve natural shoreline projects have been installed basin-wide.

The 2003 restorations include the Pheasant Branch Stabilization Project, Stricker Pond Project, and Tiedemon Pond Project in Middleton as well as projects in Hustisford and on Whitewater Lake. The Middleton and Hustisford Projects were implemented through state grants and involved large-scale plantings. The Pheasant Branch Creek, Hustisford, and Whitewater Lake Projects are using innovative bioengineering techniques.

In the spring of 2003, the RRC received a grant to work with nine municipalities to design shoreline restorations in their parks. The design work is scheduled for 2004.

Send Your Legislator Down the River

The third annual 'Send Your Legislator Down the River' educational event was held on June 16, 2003. Present were Representative David Ward, State Senator Judy Robson, Representative Steve Nass, Helen Forbeck (US Representative Tammy Baldwin's aide), DNR Secretary Scott Hassett and DNR Water Division Administrator Todd Ambs, along with 40 participants. The event began with Aztalan tours, the Rock River Coalition's Annual Meeting, a picnic supper, an overview of the Aztalan Master Plan and comments from the officials before everyone canoed from Aztalan State Park to Jefferson. The 2003 event was also co-sponsored by UWEX, DNR, Lake Mills-Aztalan Historical Society and the Friends of Aztalan.

Environmental Action Projects

Rock River Basin Environmental Action Guide

An environmental action guide for use by community groups in the basin was completed by Suzanne Wade, UWEX Rock River Basin Educator and Ellen Rulseh, Rock River Coalition Outreach Coordinator. The guide highlights activities such as controlling invasive plants, restoring prairies, developing rain gardens, and providing groundwater education.

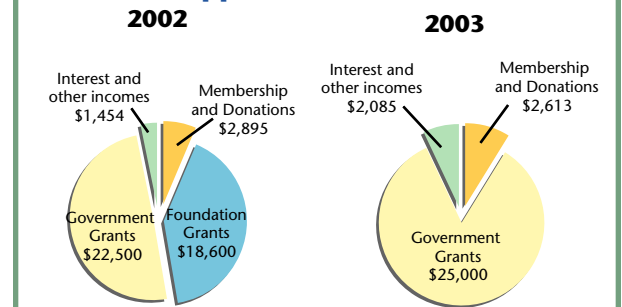

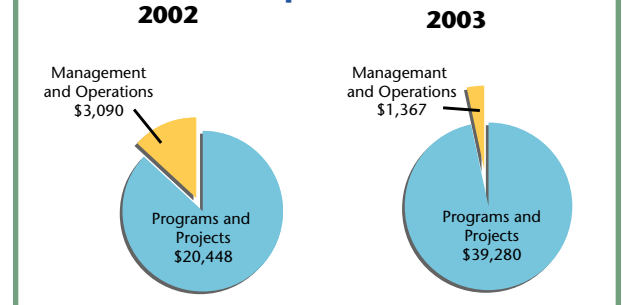

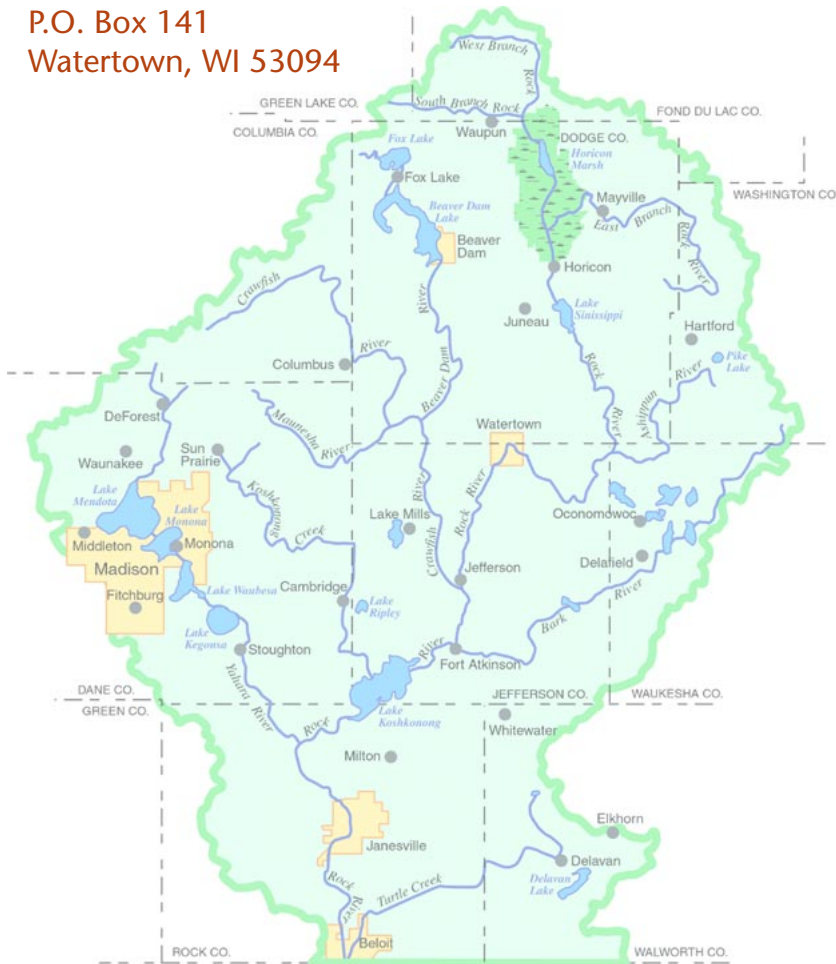
